- Accela Post go live Status We are live!
 - ~9500 permits and licenses for all agencies combined have been created in the new Accela system since go live.
 - ACA usage and payments by citizens has began without advertising the site
- Prior to go live Accela agreed to complete the 24 open items
 - 83 identified issues/7 scripts and 2 reports require updates
 - 2 Active Salesforce cases transition to CRC
- 95 additional Go Live issues were found in the month since 10/31/2016
 - 18 critical are open and assigned to Accela
