COVID-19 Vaccine Redistribution Options

Introduction

The Nevada State Immunization Program (NSIP) has developed redistribution plans to allow for increased accessibility of Pfizer COVID-19 vaccine for individuals aged 12 and older.

Providers enrolled in the Nevada COVID-19 Vaccine Program may receive Pfizer COVID-19 vaccine through direct shipment in increments of 450 doses or 1170 doses.

Many providers find it difficult to store and administer the current minimum order sizes of 450 or 1170 doses and the redistribution plans outlined below will allow for access to smaller more manageable quantities (6 doses- 444 doses).

Enroll in the COVID-19 Vaccine Program

Whether receiving vaccine through direct shipment or by utilizing one of the redistribution options,

enrollment in the Nevada COVID-19 Vaccine Program is a requirement in order to store, handle and administer COVID-19 vaccines and includes the following for program participation:

1. Must be enrolled in NV WEBIZ and have a PIN number.

2. Must have two staff members trained in data entry and inventory management in NV WEBIZ.

3. Must have a stand-alone freezer and/or a stand-alone refrigerator.

4. Must use a digital temperature monitoring device (data logger) for continuous monitoring of the refrigerator/freezer where vaccine will be stored.

5. Must document all COVID-19 vaccines into an Electronic Medical Record System within 24 hours and into NV WebIZ within 72 hours of vaccine administration.

6. Must report on hand inventory daily to Vaccine Finder, a federal requirement.

7. Must conduct weekly COVID-19 vaccine inventory reconciliations in NV WebIZ.

Transporting Vaccine

For ALL vaccine transports:

- Vaccine must be transported in a stable storage unit and monitored with a digital data logger (DDL).
- Record the time and minimum/maximum

temperature at the beginning of transport. In most instances, packing materials that vaccines were initially shipped in are not meant for reuse (the most common exception is ultra-cold vaccine shipping materials).

• Transport equal amounts of vaccines, diluents, and ancillary supplies (including vaccination record cards and PPE).

• Immediately upon arrival at the destination, the DDL should be downloaded and the information emailed to <u>DPBH-AVARS@health.nv.gov</u>

• Vaccines should be stored in an appropriate storage unit with a DDL.

Materials Necessary for Transporting Vaccine

1. **Portable vaccine refrigerator/freezer units**, such as a VeriCor cooler, is the preferred option if not available then use:

- Hard-sided coolers or Styrofoam[™] vaccine shipping containers;
- Conditioned frozen water bottles; OR
- Insulating material You will need two of each layer:

o Insulating cushioning material – Bubble wrap, packing foam, or Styrofoam[™] for a layer above and below the vaccines, at least 1 in thick. Make sure it covers the cardboard completely. Do NOT use packing peanuts or other loose material that might shift during transport.

o Corrugated cardboard – Two pieces cut to fit interior dimensions of cooler(s) to be placed between insulating cushioning material and conditioned frozen water bottles

2. Temperature monitoring device – Digital data logger (DDL) with buffered probe. Accuracy of +/-1°F (+/-0.5°C) with a current and valid

certificate of calibration testing. Pre-chill buffered probe for at least 5 hours in refrigerator.

Temperature monitoring device currently stored in refrigerator can be used, as long as there is a device to measure temperatures for any remaining vaccines. Providers picking up vaccine should use the backup data logger, required for program participation, while transporting vaccine. Independent pharmacies serving as depots will be eligible to borrow up to two data loggers from the Nevada State Immunization Program for the purpose of transporting COVID-19 vaccine to requesting providers.

Options for Obtaining Vaccine

Option 1 – Independent Pharmacy Depot

An enrolled COVID-19 vaccine provider can work with one of the independent pharmacies listed in Figure 1 to obtain Pfizer COVID-19 vaccine. Providers should contact the independent pharmacy by phone to request the vaccine quantity.

Arrangements for vaccine pick up or drop off will be agreed upon between the provider and the pharmacy depot. Pharmacy depots must verify that the requesting party is an enrolled provider with a PIN number by visiting

https://dpbh.nv.gov/Programs/Immunization/COVI D/COVID-19 Vaccine Provider Verification/ to review the most current list of eligible providers. The list of providers and PIN numbers will be updated weekly as new practitioners are on

boarded.

Filled order requests will be reported weekly by pharmacy depots to the following link: https://dpbhrdc.nv.gov/redcap/surveys/?s=FCHCLK3

HHY. Vaccine providers receiving doses will input the newly transferred inventory into NV WebIZ to manage.

Option 2 – Provider Pick Up from Local Health Authority

An enrolled provider may request to pick up COVID-19 vaccine from a Local Health Authority (LHA), see Figure 2. LHAs must verify that the requesting party is an enrolled provider with a PIN number by visiting <u>https://dpbh.nv.gov/Programs/Immunization/COVID/</u> <u>COVID-19 Vaccine Provider Verification/</u> to review the most current list of eligible providers. The list of providers and PIN numbers will be updated weekly as new practitioners are on boarded.

Vaccine transfers must be executed in NV WebIZ by the LHA and the receiving providers must accept and manage the inventory received in NV WebIZ. All executed transfers should be reported on a weekly basis by the LHA here:

Note: Carson City Health and Human Services will soon have ultracold storage capacity. Until then, the Nevada State Immunization Program will serve as the local depot in place of Carson City Health and Human Services.

Option 3 – Rural Redistribution

Enrolled providers in rural Nevada can order minimum dose requirements of 450 or 1170 doses for direct ship, see Figure 3. Direct ship orders generally arrive the week following order submission using this link: https://dpbhrdc.nv.gov/redcap/surveys/?s=844K7JA3 MK

Orders sizes between 6 doses and 444 doses will require transportation arrangements to be made from one of the neighboring county partners with an ultracold vaccine storage unit listed below. Transferring providers must verify that the requesting party is an enrolled provider with a PIN number by

Vaccine transfers must be executed by the redistributing partner in NV WebIZ and the receiving providers must accept and manage the inventory received in NV WebIZ. Vaccine transfers that have been completed should also be reported on a weekly basis here

Pfizer COVID-19 vaccine will also be distributed by NSIP staff and partners to parts of rural Nevada and will be delivered every last Monday of the month to Mineral County, Esmeralda County, Nye County, and Lincoln County.

Enrolled providers can submit Pfizer COVID-19 vaccine requests using the following ordering link: https://dpbhrdc.nv.gov/redcap/surveys/?s=844K7JA3 MK Orders must be received by close of business one week before delivery is scheduled.

Option 4 – Hub and Spoke Model

Large medical systems can enroll in the Nevada COVID-19 Vaccine Program as the hub and make smaller portions of the Pfizer COVID-19 vaccines available to enrolled affiliated providers as the spokes. Enrollment in the Nevada COVID-19 Vaccine Program is a requirement for both the hub (large medical systems) and spokes (affiliated providers) in order to store, handle and administer COVID-19 vaccines. 
